OTP-CR-313/04: Criminal Attacks on Internet Service

With regard to your duties as representatives of the Federal Bureau of Investigation, Please observe that I have reported the attached complaint (addressed to Winston Fullerton, Technical Support Manager, Columbus Communications Jamaica Limited (FLOW)) to FBI Tips and Leads. I expect you to bring the matter to the attention of the appropriate superior officer responsible for such investigations.

The complaint concerns the ongoing stalking operations organised from the United States for which MIT Professor James H. Williams Jr. is instrumental in its commission. As you are aware, the complaints continue to be obstructed by all law enforcement authorities with jurisdiction – including the Regional Security Office of the US Embassy.
