1. I hereby give notice pursuant to sections 7 and 10 of the Data Protection Act 1998 (the Act):
 - a) **NOTING** that the University of Aberdeen (the University) - a Recognised Body granted degree-awarding powers accredited by the Privy Council of the United Kingdom – by failing to adduce evidence to rebut the presumption of institutionalized racial discrimination established on a preponderance of evidence by Commission for Racial Equality principal officers Gerry German and Kuttan Menon, in the period 1983 to 1985, converted the prima facie evidence found to proof beyond a reasonable doubt, thereby admitting to a policy of institutionalized racial discrimination;
 - b) **NOTING** that the University's intent to maintain the systematic, institutionalized racial discrimination so admitted, to oppress black/non-white students in engineering by fraudulently demoting their rightful Honours examination marks in relation to their white peers as evidenced by the University's own records and publications, notably the data establishing artificial construction of a narrow II-2 to III band confining the Honours marks of all black/non-white engineering students in 1983¹ - is proscribed by international law as the crime against humanity of *apartheid*;
 - c) **NOTING** my discovery in 1996 of the theft of property constituted by rights in and to my Honours thesis "Interactive Computer Package Demonstrating Sampling Convolution and the FFT" (the Honours Thesis) submitted April 1983 - a mandatory component of the examination worth 2/7 the total Honours mark - the forgeries dated 12 January 1998 and 15 May 1992 purporting to be my student transcript certifying the award of Bachelor of Science in Engineering Honours,² the Honours designation and degree class of "Second Class (Division 2)" falsely accounting for the Honours Thesis as "achieved", deceptively serving to conceal the theft and, in consequence, the degree award as *ultra vires ab initio*, null, void, and bogus;
 - d) **NOTING** that in consequence of my further allegations of theft dated 7 October 2002 (copies of which I also distributed to faculty and senior members of the administration of the Massachusetts Institute of Technology (MIT)), the University unwillingly, and secretly, rescinded the degree of Doctor of Philosophy in Engineering awarded July 1985 to Colin Sinclair MacLean, my submissions having adduced evidence that his PhD thesis "Development of a Microprocessor-Based Signal Analyser for Machine Condition Monitoring" (the PhD Thesis) relied in essence on the entire Fortran code (the Fortran Program) underpinning my Honours Thesis as the sole determinant of the "distinct contribution to knowledge affording evidence of originality as shown by the exercise of independent critical powers" that

satisfied the requirements of the doctoral award stipulated by the University Academic Standards Committee;

- e) **NOTING** that the rescission in March 2003 of MacLean's PhD was pursuant to a finding by experts appointed by the University that the machine code in the PhD Thesis was a copy of my entire Fortran Program and, further, that I created the Fortran Program in October 1982 (the beginning of my Honours year) on the Honeywell 66/80 mainframe in my account, under my user id "uen4059", where I developed the code until April 1983, the third year of MacLean's doctoral programme;
- f) **EMPHASIZING** that the University website reveals regulations which stipulate that "Transcripts do not include any courses 'Not Achieved', whether through failure or lack of attendance";³ and that the University Code of Practice on Student Discipline prescribes that where a student is found to have cheated "the student shall be awarded zero marks" for the component of assessment in which cheating is found;
- g) **NOTING** that the University's publication of the forgery dated 12 January 1988, reconfirmed by the further forgery published 15 May 1992, purporting to be my student transcripts, do not include my Honours Thesis, the Honours Thesis having been awarded a mark of zero, and accounted for as "not achieved";
- h) **NOTING** that subsequent to my allegations of theft, the University's publication of the further forgeries dated 24 April 2002 and 10 February 2003, purporting to be my student transcript and statement of marks recording the title of my Honours Thesis and associated fictitious mark of 240/400 (60%), falsely account for the existing mark of zero awarded, and the corresponding status of the Honours Thesis as "not achieved" concealed and maintained by the University;
- i) **ASSERTING** that in accordance with the policy of *apartheid*, while the University by reason of the rescission of MacLean's doctoral award have established conclusively that I am the author of the Fortran Program, they have retained the property valued as a PhD denying, through false statements,⁴ the finding of plagiarism of my Fortran Program that resulted in the rescission - refusing to credit me as author of the work with intent to permanently deprive me of the property;
- j) **NOTING** that the record of documents in the matter, being published at <http://www.abertheid.info/> evidence the University's false accounting, forgeries, and otherwise false statements uttered as genuine, intended to achieve the practical result of retaining property obtained by deception, thereby maintaining the bogus degree awarded;
- k) **RECOGNIZING** that my two-month (February to April 2009) reproduction of the Fortran Program developed for GNU C-Graph corroborates my claim to sole authorship of the Honours Thesis;^{5 6}

- l) **ASSERTING** that I authored GNU C-Graph for the purpose of donating the software to the GNU Project; that GNU C-Graph will never serve the criminal purposes of the University; that I fulfilled in its entirety the requirements for the award of Bachelor of Science in Engineering Honours in 1983; that in respect of the decision of the University Academic Standards Committee noted in paragraph 1 (d) above, a court will declare my entitlement to the award of Doctor of Philosophy in Engineering; that GNU C-Graph is not available to the University as an assessment component towards fulfilment of any kind of degree, whether Bachelors, Masters, or Doctoral degree; and that I reject, out of hand, any enticements in this regard being contemplated by the University;
- m) **RECOGNIZING** that the University's statements of 29 January 1998, and 21 June 2002 falsely claimed that the third and fourth year examination scripts and associated data of the engineering graduating class of 1983 (the Scripts) had been destroyed, the University having recognized that rights of recovery in respect of fraud and theft are imprescriptable; that the University Registrar's wilful misrepresentation of the law governing prescription by Privy Council Ordinance No. 5 (General No. 2)⁷ was in aid of the continuing extortionate attempts exemplified by the University's letters of 25 April 1991, and 8 May 1996 advising me to graduate so as to induce my consent to the fraud thereby causing the abandonment of my property and all rights of recovery; and that these false representations were commissioned with intent to destroy the evidence, as without such graduation the obligation to preserve the Scripts subsists without prescription;
- n) **NOTING** that the data held by the University includes the marks determined by the independent assessment of the said Scripts conducted by Professors at the Massachusetts Institute of Technology in the period December 1991 to January 1992, that these marks proved that my examination performance in the third and fourth years of study at the University merited first place (in a category without peers), that two of my Honours examinations (Engineering Mathematics IVA and Control Systems IVA) merited 100%, and that the University seeks an opportunity to destroy the Scripts because of their knowledge that the marks awarded by the internal and external examiners of the University are false;
- o) **RECOGNIZING** that the ongoing 32-year programme to extort the surrender of my rightful property and cover up the crimes employs not only the denial of opportunity for legitimate doctoral study, but subversion of my juridical personality, the denial of livelihood and threat to life itself, attacks on liberty, stalking, psychological battery, false imprisonment, cruel treatment, ravages to social environment, menaces, murders (commissioned by MIT Professor James H. Williams Jr. acting for the criminal enterprise) including that of my fiancé Haitian-Bahamian attorney-at-law Eliezer Regnier on 27 February 2010,⁸ and attacks on my family causing me to continuously fear for our lives;

- p) **NOTING** that the wilful exercise of such control presuming powers attaching to the right of ownership over a person - enabled by the blanket obstruction of justice by the CRE, the Metropolitan Police Service,⁹ the International Criminal Court which has failed to register the complaints,¹⁰ and other authorities intended to conceal the *apartheid*, and to coerce my return to the University (aided by a false written invitation in 1985 to apply to the PhD Programme in Engineering) so as to exact the products of my intellectual labour by falsely crediting whites as authors of my work and by further theft - constitutes enslavement;
- q) **RECOGNIZING** that the Honours marks held by the University for white and black/non-white students in the School of Engineering, being artificially constructed in accordance with the policy of *apartheid*, are materially false; and that in disclosing the data requested any officer of the University who makes, executes, endorses, signs, seals, or certifies false data does so with intent to defraud;
- r) **EMPHASIZING** that the University has no power to “close the case”: that such false assertions serve only to corroborate the intent to maintain the regime of *apartheid* and to permanently deprive me of my rightful property; that such statements intended to induce me to take no further action are themselves fraud and can not relieve the University of its legal obligations, including obligations of rectification and disclosure under the Act;
- s) **NOTING** my [complaint](#) filed 25 March 2015 with the Metropolitan Police Service,¹¹ and that I shall continue to file such complaints until the crimes commissioned have been prosecuted;
- t) **DETERMINED** that justice shall prevail;

The Subject Access Request pursuant to section 7 of the Act (the SAR) contained in my Notice of Forgery dated 6 January 2004, and letters of demand dated:

- 7 March 2003,
- 30 December 2002,
- 23 December 2002,
- 7 October 2002,
- 4 April 2002,
- 24 November 1997 (for which the University have fraudulently accepted £16.00 as fee),

and which was amended by my further SARs of 13 January 2012 and 31 March 2015 (this document), is hereby repeated and incorporated as if fully set out in this paragraph. In accordance with the first and fourth Data Protection Principles, the University shall rectify, make fair, accurate, up to date and compatible with legitimate purposes all data of which I am subject.

2. Having particular regard to the items of, and amendments to, the SAR enumerated below, the University shall disclose:

- a) A description of all data of which I am subject (the Act, section 7(1) (b)).
- b) My "Transcript of Records" or "Statement of Marks" whose specified purpose is to complete the application requirements for the PhD programme in Electrical Engineering and Computer Science at MIT. The Statement shall declare all courses/units taken, the percentage mark/grade and class rank for each assessment component (e.g. 1/69, 1/43), my overall rank in the engineering graduating class of 1983, as well as the title of the degree (Bachelor of Science in Engineering) and degree class (First Class Honours) to which I am entitled. The degree class of First Class Honours shall be qualified to reflect the fact that the standard I achieved was without peers.

The University shall provide one original and two certified copies of my "Transcript of Records" or "Statement of Marks" bearing the signature of the Academic Registrar and the seal of the University. The aforesaid documents shall be returned immediately to my Jamaican postal address given on page 1 of this form. I emphasize that the document to be disclosed is not the "transcript" referred to by the University Secretary's letter of 21 February 2003, which claimed that transcripts for "students registered prior to 1992 [do] not include any marks or class ranking", as disclosure of such a document pursuant to this SAR is incompatible with the specified purpose of completing the requirements of my doctoral application to MIT.

- c) An electronic copy of the source code of my Fortran Program stored under user ID uen4059 in the Honeywell backups for 1983 kept by your Directorate for Information Technology (DIT, formerly known as the University Computer Centre). Your false claims of 10 July 2002, 10 February 2003, and 28 November 2003, denying

possession of copies of my Fortran Program comport with your concealment of the rescission of MacLean's doctoral award in March 2003 (above, paras 1 (d) and (e)). The copy of my Fortran Program shall be disclosed on CD.

- d) An electronic copy of the Fortran source code that I authored to generate the frequency response graph submitted in my one-week Honours Engineering Design Project in December 1982. This Fortran code (named "MAGLEV") is also stored under my user id "uen4059" in the Honeywell backups kept by DIT, a printout of which is attached to the project report that your letter of 21 October 1983 affirms was reviewed by the external examiners. My Fortran code for MAGLEV shall also be disclosed on CD.
- e) A copy of the computer printout of my Fortran Program (the Printout) that I signed in the presence of Engineering support staff Ann Shipley and Heather Flett, that along with the typed manuscript (the Text) comprised my Honours Thesis which, witnessed by Flett, was submitted to and received by Shipley on behalf of the Head of Engineering, in April 1983.
- f) All internal and external examiners' comments and reports concerned with the assessment and external review of my Honours Thesis and Design Project. As the University's letters of 12 October 1983 and 21 June 2002 stated, the external examiners submitted reports to the University after reviewing all assessment components for the Honours degree including the Honours Thesis and Design Project. Contrary to your Academic Registrar's false and deceptive email of 28 November 2002, I made no request for examination scripts. As the Information Commissioner's Data Protection Good Practice Note on "Individuals' Rights of Access to Examination Records" advises,¹² examiners' comments are disclosable under the Act.
- g) All comments and reports made by the experts appointed by the University for investigating my allegations against the PhD Thesis (above, para. 1 (e)), who by a process of reverse engineering identified the machine code in the PhD Thesis as a complete copy of my Fortran Program, culminating in the rescission of MacLean's

doctoral award.

- h) The University's formal decision to rescind MacLean's doctoral award pursuant to their review of the latter-mentioned expert investigation into my allegations against MacLean's PhD Thesis.
- i) All reports, statements, and other information pertaining to any examination offences allegedly commissioned by me; the proceedings undertaken for such offences, and the disposal of such proceedings (the Act sections 2 (g) and (h)).
- j) All information on: proceeds, honours, awards, privileges, and rights, accruing from my Fortran Program, its derivatives and adaptations; use by the University, Shell, or other parties, and accounts of all intrusions with the trust property.
- k) The list of degree results for the entire engineering Honours graduating class of 1983 (the List) of which I am data subject, which enumerated the Honours degree classes awarded, which was published: in the University Calendar, on the University notice-board, and by the Press and Journal in June 1983. Contrary to the aforementioned false statements of 28 November 2002 denying the University's obligations of disclosure, the List is an accessible record (the Act, section 68 (1) (b)) for which the students who are identified have given their consent (the Act, section 7 (4) (a)) to publication by virtue of their student contracts which recognize the customary practice of making the List available to the public.
- l) The List, rectified in respect of the fraudulent assignment of fictitious marks to accord with the policy of *apartheid*, having regard to the restitution of rights in and to any Honours theses/dissertations of which black/non-white students have been defrauded, and the concomitant rescission of those Doctoral awards which may have benefited from theft, copyright infringement, or plagiarism of the expression, ideas, or discoveries in work belonging to such black/non-white students. The University will recognize that the duty to rectify extends to the data pertaining to all engineering students, past and present.

3. The University will apply the following copyright notices to rectify data referencing both my Honours projects:-

I attach payment information from your online store certifying receipt of £30.5 GBP in respect of order numbers UOA102948 and UOA102949 as fee (the Act, section 7 (2) (b)) to include the prescribed £10 and the additional cost incurred in disclosing the "Transcript of Records" or "Statement of Marks" specified in paragraph 2(b) above. The University will have particular regard to breaches under the Act concerning the attempt to abrogate obligations of disclosure in respect of my SAR of 13 January 2012 - as the return of National Commercial Bank Jamaica Limited cheque No. 184908 for £25 GBP amounted to no more than a mere waiver of the fee.¹³ The University will also have regard to the fraudulent non-disclosure pursuant to acceptance of my previous SAR payments amounting to £16 GBP (National Commercial Bank Jamaica Limited cheque No. 075455 for £6 GBP, and Canadian Imperial Bank of Commerce cheque No. 005466 for £10 GBP sent by letters dated 4 April 2002, and 30 December 2002 respectively).

6. Nothing in this Subject Access Request (the SAR) made under the Act shall undermine or affect any right, title, interest, or demand, or be construed as derogating from any right of action or other remedy (whether civil or criminal) in the cause. Failure to disclose the data legitimately requested is a violation under the Act and fraud, as a court will hold that public bodies, such as the University of Aberdeen, do not enjoy the privilege of self-incrimination conferred by schedule 7, paragraph 11 of the Act.

7. DATA SUBJECT NOTICE

Under section 10 (1) of the Act, I demand that the University and their agents immediately cease and desist from the aforesaid processing in aid of apartheid, theft, fraud, and the other underlying crimes delineated in paragraphs 1(o) and (p) above that continue to cause the intended irreparable damage, distress, destruction, and death.
